### Report on the Financial Statements

We have audited the accompanying Standalone financial statements of **M/s.   - f. With respect to the adequacy of the internal financial controls over financial reporting of the Company and the operating effectiveness of such controls, refer to our separate Report in




- i. (a) The Company is maintaining proper records showing full particulars, including quantitative details and situation, of fixed assets.



### A Basis of accounting and preparation of financial statements
